Consequent upon the realization of vacant seat positions in UG Programme under B.V.Sc. & AH & B.Sc.(Hons.) Agriculture programme, the following waitlisted candidates issued vide notification No: 13 (Acad.) of 2022 dated 17/01/2022 and hereby informed to deposit the prescribed fee mentioned against each category (refer details at "A" & "B" below) through online or offline mode in favour of the following A/c holders (stream wise) of J&K Bank on or before 7th April 2022 failing which the invitation extended to them shall be treated as cancelled and such invitees shall have no claim on the seat.

The above candidates shall have to deposit their fee on or before stipulated date and report to the office of the Registrar on or before 7th April 2022 during office hours alongwith the original certificates, two sets of self attested photocopies of testimonials and 3 Passport size photographs for filling up of the admission form (which can be downloaded from the University website <u>www.skuast.org</u>.

The candidates thereafter shall have to report to the concerned Dean of the Faculty for registration in the 1st year /1st semester of the academic session 2021-22.
