Proposed Guidelines for International Training Programmes (students)
under NAHEP-IDP, SKUAST-Jammu

1. Students who are interested to undergo international training under NAHEP-IDP shall apply in the proforma prescribed along with undertaking and submit duly filled application with relevant documents to the Deans of their respective faculties.
2. Overall, 33.33 percent of the slot will be reserved for girl students. In case, the girl's enrolment is overriding boys, due representation will be provided after approval from university and ICAR.
3. Final evaluation and scoring for deciding the eligibility shall be within the categories identified as per Equity Action Plan (EAP).
4. Identified students should possess minimum attendance prescribed by the university in all the subjects.
5. Candidate should possess a CGPA of 7.5 and above and should not have any repeat courses as on the date of cognitive evaluation (Examination). However, if the students belonging to SC/ST category are not available with CGPA Grading of 7.5, then relaxation shall be provided from CGPA Grading 7.5 to 7.0 for students of SC/ST with the approval from the PIU, NAHEP.
6. It is mandatory for all the eligible candidates to appear in the cognitive evaluation. Date for evaluation will be notified separately.
7. Each student will be considered for only one programme.
8. Students will be called in the ratio of 1:3 for interview and presenting statement of purpose.
9. Candidates are entitled for the training only for the sanctioned duration and no extension of the period of training shall be entertained.

10. The trainee should make presentation and should submit the compliance report within a month after completion of programme in prescribed format developed by SKUAST-Jammu.
11. Identification/ selection of the candidates for the international training and choice of training to which the candidate has been selected lie with the University. The training programme for which a student is deputed shall be subject to finalization of training arrangement with the host(foreign) university. The decision of the University administration shall be final in all matters.
12. The candidate should submit documentary proofs to claim scores under prescribed parameters.
13. A committee constituted with the approval of competent authority of the University would conduct the interview of the eligible candidates.
14. If the candidate fails to complete the training period, then the candidate will be liable to pay back the total expenditure incurred by the NAHEP in deputing the candidate for the international training along with interest on the said amount compounded annually from the date of availing of the grant, at prevailing government rates.
