**Sub: Provisional Admission to B.V.Sc. & A.H. / B.Sc.(Hons.) Agriculture/ B.Sc.(Hons.) Horticulture/ B.Tech. Agriculture Engineering / B.Tech. Dairy Technology/B. Tech. Biotechnology programme for the academic session 2023-24.**

Consequent upon the recommendations of the Admission cum Counselling Committee the selected candidates as per the list (stream wise) enclosed as **Annexure-I , Annexure-II , Annexure-III, Annexure-IV, Annexure-V and Annexure-VI** to this notification are granted provisional admission in the academic session 2023-24, subject to the condition that if at any point of time during the course of study programme, information furnished by a selectee is found incorrect or misrepresented/concealed or suppressed in any form, the admission granted would be cancelled forthwith without assigning any reason and this University shall be at liberty to initiate the necessary action under rules against such selectee.

The selectee who have attended the counselling, but has not paid the prescribed fee as indicated against his/her name in the selection list, shall be treated as cancelled and the seat in that case be declared as vacant which subsequently shall be filled from the waitlisted candidates or in the next round of counselling, as the case may be.

The provisionally admitted/selected candidates are advised to report to the office of the Registrar on or before **24-08-2023** during office hours along with the original certificates, two sets of self attested photocopies of testimonials and 3 Passport size photographs for filling up of the admission form (**which can be downloaded from the University website.) The candidates thereafter shall report to the concerned Dean of the Faculty (along with a complete set of all the documents & 03 Nos. of Passport size photographs) for registration in the 1<sup>st</sup> year /1<sup>st</sup> semester of the academic session 2023-24.

The candidates who fail to report for admission in the University by **24-08-2023 up to 5 p.m.**, his/her admission shall be treated as cancelled.
