- WHEREAS, University, conducted OMR based Objective type written Test Examination of all the applicants of aforesaid positions on 04.12.2022.
- WHEREAS, on the basis of performance of the candidates in OMR based Objective type Written Test Examination conducted on 04.12.2022, **coupled with the additional weightage points awarded to the candidates by the designated committee**, the result of the candidates was declared vide no. AUJ/Secy./23-24/SLF-14/1815-1817 dated 17.10.2023.

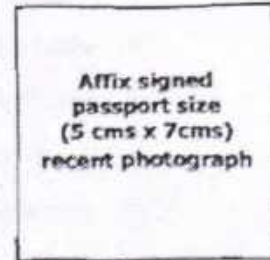


