

- 1. All enclosures to be attached with the online application form including score card to be self-attested by the candidate.
- 2. Candidates must enter the relevant scores in the Score Card Proforma and must be supported by the documentary evidence (duly self-attested) without which no claim on account of Score will be entertained. It shall be mandatory for the candidate to mark Page No./s on all the supporting documents and refer that page No. against concerned activity/ies in the score card, wherever required.
- 3. Certificates in support of qualification must have been obtained from duly recognized University/Institutions or organizations/departments, as the case may be.
- 4. The reservation policy and reservation roster in Teaching positions of SKUAST-Jammu (at the level of Professor/Associate Professor/Assistant Professor & equivalents), is as specified by UGC/MHRD (amended from time to time). OTHER IMPORTANT INSTRUCTIONS

- Before filling up the application form, the candidates are advised to read General Instructions, Essential Information and Other Important Conditions carefully

- After the interview, in case of selections the appointment will be provisional and is subject to the caste certificate being verified through the proper channels. If the verification reveals that the claim of the candidate to belong to ST/SC/OBC (non-creamy layer)/EWS is false, his/her services will be terminated forthwith without assigning any further reasons thereof and without prejudice to such further action as may be taken under the provisions of Indian Penal Code for production of false certificate.
- The appointment letter to the selected candidates shall be issued only after to verification of character & antecedents and caste certificate by the competent authority. In case the report with regard to his/her conducts, character, antecedents, caste certificate etc., is found to be unsatisfactory or false, the appointment shall be canceled/terminated forthwith.
- The selected candidates shall be required to perform duties as per the Rules of the University, as amended from time to time. 

- In case of any inadvertent mistake in the process of selection which may be detected at any stage even after the issue of the appointment letter, the University reserves the right to modify/withdraw/cancel any communication made to the candidates.
- ❖ Information uploaded on the university website shall not be provided to the candidate under RTI Act, 2005. The information uploaded on the university website shall remain for a specific period only. Therefore, the candidates are advised to download the information and keep them for future reference, In midway of recruitment process neither any application under RTI Act, 2005 shall be entertained nor shall any information be provided. 
