2. Position is purely temporary basis and co-terminus with the project. Selected candidate will not be entitled for any claim for regular appointment/ absorption in SKUAST-Jammu or in sponsoring agency in future.
3. The scheme is sanctioned upto 30th September 2022 for the financial year 2022-23. Hence, the person employed shall not claim for continuation of the employment after the termination of the scheme. However, It is likely that the sponsoring agency may extend the project for this or next financial year i.e. 2022-23 or onwards, in which case the service of the person engaged on contractual basis is liable to be extended subjected to satisfactory performance and availability of the funds.

The eligible candidates who shall submit the application form complete in all respects within the specified time shall be called for attending the provisional personal interview to be held in the office of Directorate of Research, SKUAST-Jammu subjected to the verification of the original documents at the time of interview.
5. Mere attending the interview shall not be treated as eligible for the post.
