- Sub: Compassionate appointment of Mr. Kuljeet Kumar S/o Late Sh. Minder Kumar, Ex. Orderly-cum-Chowkidar, SKUAST-Jammu under SRO-43 of 1994.
- Ref: 1. Concurrence of Finance Department conveyed vide no. FA/Uni/33/SKUAST-J/SRO.43/2021/813 dated 18.04.2022, in light of Govt. Order No. 377-F of 2019 dated 04.07.2019 issued by the Finance Department, J&K Govt.
  - Verification of Character and Antecedents conveyed by Dy. SP (Hqrs), For Spl. Director General CID J&K, Criminal Investigation Department, Government of Jammu & Kashmir issued vide their no. CID/MR/(SRO-43) 461/2022/670 dated 27.06.2022, in light of Government Order No. 528-JK(GAD) of 2021 dated 21.06.2021 issued by the General Administration Department, Govt. of J&K, Civil Secretariat, Srinagar.

Sanction is hereby accorded to the temporary appointment of Mr. Kuljeet Kumar S/o Late Sh. Minder Lal, Ex. Orderly-cum-Chowkidar, SKUAST-Jammu R/o Village: Gandli, P/o Dablehar, Tehsil R.S. Pura, District Jammu, UT of J&K – 181 111 as Orderly-cum-Chowkidar (Class-VI) as per Scheduled I to Chapter III (General Administration Cadre), in the pay band (Rs. 4440-7440) with grade pay of Rs. 1300/-(Pre-revised), Pay Level-SL 1 (14800-47100) under SRO-43 of 1994.

The appointee shall report to the Division of Veterinary Public Health & Epidemiology, FVSc. & AH, SKUAST-J, R.S. Pura with in a period of 21 days from the date of issuance of this order and shall be allowed to join only on production of the following documents/certificates (in original) to be verified subsequently:

- 1. All Academic qualification certificates.
- 2. Matriculation/Date of Birth Certificate.
- 3. Health Certificate issued by the Chief Medical Officer.
- 4. Domicile Certificate issued by the Competent Authority.
- 5. Category Certificate issued by the Competent Authority, if any.
- 6. Certificate from the concerned office (Deputy Director, Employment and General Manager, DIC) to the effect that no loan under self-employment scheme is pending against the selectee.

The appointment of the appointee, shall further be subject to the following conditions:

- (a) The appointee shall give an undertaking in the shape of an Affidavit to the effect that if on verification, his Qualification/Date of Birth from the concerned issuing authorities is found fake/forged his appointment as Orderly-cum-Chowkidar shall be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against him.
- (b) The salary of the appointee shall not be drawn and disbursed to him unless the satisfactory reports in respect of genuineness of Qualification/Date of Birth is received from the concerned authorities/agency.

- (c) The appointment of the candidate shall be governed in terms of rules as prescribed under the relevant recruitment/service rules of SKUAST-Statutes /JKCSR and the further amendments to be taken in SKUAST-Statutes from time to time with regard to Jammu & Kashmir Probationer (Condition of Service, Pay and Allowances) and Fixation of Tenure Rules, 2020 notified vide S.O. 192 of 2020 dated 17th June 2020 as well as University notification no. 13 (Secv.) of 2022 dated 02.08.2022.
- (d) The appointment of the above candidate shall be subject to outcome of writ petition(s), if any, pending before Competent Court of law.
- (e) The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO 400 of 2009 dated 24.12.2009.
- (f) If the appointee fail to join within a period of 21 (twenty one) days from the date of issuance of this order he shall forego his right of appointment which shall be deemed to have been cancelled ab-initio without any further notice.
