

  the same day or any other subsequent date convenient to the opening authority.

# Terms & Conditions:

The terms and conditions of the NIT are as under:

- Tender form and other details can be had from the Dean Students Welfare office, SKUAST-J Chatha against payment of Rs.500/- (Non-refundable) bank draft in favour of Comptroller SKUAST-J, Chatha. The tender document can also be downloaded from the website www.Skuast.org
- The tender must be accompanied with earnest money amounting of Rs. (ii) 2000/- in the form of CDR/TDR pledged to Comptroller SKUAST-Jammu. (iii)
- The tender without CDR will be out- rightly rejected.
- Conditional tenders are liable to out-rightly rejected. (iv)
- If the date on which the tenders are to be received is declared as a public (V) holiday, the tender will be received on the next working day. (vi)
- Tenders must be subscribed as "Running of Tuck Shop at Sankalp Hostel, Chatha. Tender shall only be entertained on the prescribed form of the University. The tender is liable to be rejected if mutilation, over writing and corrections are found therein, without duly attested by the tenderers.
- The University reserves the right to accept or reject any tender without (vii) assigning any reason.
- The CDR of unsuccessful tenderer shall be released within one month after (viii) the contract is finalized.
- The CDR of successful tenderer shall be released within one month after the (ix)satisfactorily completion of the contract period on production of NDC.
- The successful tenderer shall not in any case sublet the contract in full or any (X) part thereof to the third party. (xi)
- The utensils, crockery etc. shall have to be arranged by the contractor himself at his own cost. However, the covered space ceiling fans etc. shall be provided by the University.
- The University shall not be responsible for any theft or loss sustained by the (XII) Contractor during the period of the contract.
- The contractor shall be fully responsible for any damage to the University (XIII)

- (xiv) The successful tenderer shall have to execute an agreement with the University within 15 days after allotment of the contract.
- (xv) The contract shall be awarded in favour of the tenderer whosoever offers the <a href="highest rate">highest rate</a> of rent per month, excluding electricity charges which will be charged as per meter reading. The successful tenderer shall have to give an undertaking to the effect that all the dietary items whose rates have been fixed by the SKUAST-Jammu shall be charged strictly.
- (xvi) The contractor shall keep his premises (inside and outside) neat and clean.
- (xvii) All the dietary items whose rates are fixed by the University, whether profitable or non profitable shall have to be made available daily for the students/employees. All the edible items available in the canteen shall be fresh and of standard quality.
- (xviii) Representation with regard to the increase of rates fixed by the university shall be considered in the contract period only on mutual consent. The approved rate list shall have to be displayed in Canteen by the contractor permanently and shall be fully visible to the students/employees.
- (xix) The contract can be terminated at any time during the currency of the contract, if any of the aforesaid conditions of the contract are violated by the contractor and EMD amount will be forefeet's.
- (xx) In the event of termination of contract by the Employer for the non-performance of contract, the dispute between the contractor and the SKUAST-Jammu, shall be settled in the Hon'ble court of J&K at Jammu only.
- (xxi) The tenders can be rejected in whole/part by the University without assigning any reason.
