- Whereas, Fourteen (14) candidates were selected for the post of Accounts Assistant vide No: AUJ/Adm/03-04/6362-63 dated 09-10-2003.
- Whereas, two candidates namely Sh. Sanjay Ganjoo and Sh. Tsewang Dorjai did not join the University services.
- Whereas, Appointment Order and place of posting of Twelve Accounts Assistants (Trainee) was issued vide University Order No. 180(Est.) of 2003 dated 07-11-2003 wherein, it was mentioned that the inter-se-seniority of the candidates shall be reckoned in the same order in which their names appear.
- Whereas, S. Kamal Deep Singh in the waiting list was appointed as Accounts Assistant (Trainee) vide University Order No. 202(Est.) of 2003 dated 08--12-2003.
- Whereas, Sh. Kulwant Singh Sambyal was appointed as Accounts Assistant (Trainee) vide University Order No. 43(Est.) of 2004 dated 17-06-2004.
- Whereas, the first selection list was issued vide endorsement No. AU/J/Adm/03-04/ 6362-63 dated 09-10-2003 and those joined were temporarily appointed as Accounts Assistant (Trainees) vide University Order No. 180(Est.) of 2003 dated 07-11-2003.
- Whereas, in reference to the representation of Accountants (the then Accounts Assistants) and the letter of the Deputy Secretary to Govt., APD, Civil Secretariat Jammu vide No. Agri/SKUAST/Genl/06-2019 date 25-04-2019 for recasting of seniority, a Committee was constituted vide Memorandum No: AUJ/Est./G-390-D-7/19-20/4088-4094 dated 25-09-2019.
- Whereas, the committee recommended that the seniority list prepared for the post of Accounts Assistants in 2003 & 2004, further notified vide No. AUJ/Adm/06-07/3973-83 dated 22-09-2006 and AUJ/Adm/09-10/4942-50 dated 14-09-2009 may be recasted as per the merit obtained by the candidates in their initial appointment .
- Whereas, on the basis of the recommendations of the committee and approved by the Competent Authority, the tentative seniority list of Accounts Assistants appointed in year 2003 & 2004 as per marks obtained in the initial appointment was issued vide No. AUJ/Est./G-390-D-07/2021-22/1727-41 dated 30-06-2021.
- Whereas, some Accountants (the then Accounts Assistants) represented against the issuance of the seniority list issued vide No. AUJ/Est./G-390-D-07/2021-22/1727-41 dated 30-06-2021.
