		iii. Heads of Divisions/ Regional Stations /AICRIPs/KVKs/Adhoc Research Projects	Upto ₹25,000/- in a year in respect of Regional Stations and ₹50,000/- in a year in case of Faculties Full powers on the recommendations of Library Advisory Committee
1 (c)	To purchase Journals/ Periodicals / reviews/ bulletins of technical and scientific nature	University Librarian/ Heads of Regional Stations /AICRIPs /KVKs/Adhoc Research Projects or Faculties	Full powers on the recommendations of Library Advisory Committee approved by the Vice-Chancellor
2.	To sanction rate contract for purchase of stationery articles	Vice-Chancellor	Full powers on the recommendations of purchase committee. In determining the rate contract, the rate and quality fixed by the Government for similar articles shall be kept in view.
