**Terms and conditions:**

1. Any offer without CDR shall not be entertained.
2. The rates should be quoted per quintal basis.
3. Conditional bids shall be rejected out rightly.
4. The quantities mentioned above are approximate and can vary.
5. The bidder can inspect wheat and barley grain lots lying at seed store of Division of Agronomy, SKUAST-Jammu, Chatha, on any working day during office hours except gazetted holiday/Saturday/Sunday.
6. The offer should include cost of gunny bags also.
7. Envelope containing the bid amount should be labelled as "**Bid for Auction of Wheat and Barley Grains**".
8. 80% amount of accepted bids shall have to be deposited within 3 days of acceptance of the bid and rest 20% before lifting the material.
9. The successful bidder shall have to lift the auctioned materials within 5 days of issuance of authorization letter and university shall not be responsible for any kind of damage to the auctioned material whatsoever thereafter.
10. The successful bidder who fails to lift the auctioned materials within stipulated time, the next higher bidder shall be offered to lift the material on highest bid.
